SHEKU BAYOH PUBLIC INQUIRY SUBSTANCE/ SOIL ANALYSIS REPORT

We refer to our recent correspondence in respect of the above matter.

Thank you for agreeing to accept these instructions. We would be grateful if you could prepare a full written report in accordance with our instructions below. We have enclosed the undernoted productions and documents to assist you in the preparation of your expert report.

Background and Context

The Sheku Bayoh Public Inquiry was set up to examine the events surrounding the death of Sheku Bayoh, who died on the 3rd May 2015, after being restrained by police officers in the street in Kirkcaldy. The Inquiry is chaired by the Right Honourable Lord Bracadale (Alastair Campbell).

The remit of the Inquiry is to establish the circumstances surrounding the death of Sheku Bayoh; to assess the post incident management process and subsequent investigation; and to establish the extent (if any) to which the events leading up to and following Sheku Bayoh' s death, in particular the actions of the officers involved, were affected by his actual or perceived race. The full terms of reference for the Inquiry can be found on the Inquiry website here.

There will be separate evidential hearings to examine the terms of reference, where witnesses will be called to give evidence. We have recently concluded the first of our hearings, which commenced on 10th May 2022. After the hearings are completed, the Chair to the Inquiry will consider all of the evidence and publish a report, laying out his findings, conclusions and recommendations.

The Inquiry is scheduled to sit during the month of November, where your report will form part of the evidence being considered by the Chair. You will be required to attend the hearing (date to be confirmed) in person to give oral evidence before the Chair. Your report will also be disclosed to the legal representatives of Core Participants (individuals and organisations who have a significant interest in the Inquiry) before you give evidence. Your report will be made available to the public via the Inquiry website after you have given evidence. When you give evidence, you will be examined by Counsel to the Inquiry. The legal representatives of Core Participants have no automatic right to ask questions but will be provided with an opportunity to make applications to explore further lines of questioning in addition to your examination by Counsel to the Inquiry.

Confidentiality

All documents and information provided to you to by the Inquiry to undertake your report is confidential, in accordance with our Confidentiality Agreement. Accordingly, we have enclosed our Confidentiality Agreement for your review and signature.

Documents and Productions

We attach as an appendix to this letter a list of the productions to be made available to you to assist you in the preparation of your report.

All documents referred to within the appendices shall be shared securely via the Inquiry's sharing platform, Objective Connect. We will also seek the assistance of Police Investigations and Review Commissioner to securely deliver all physical evidence listed within the appendices to your lab. We will similarly arrange for the physical evidence to be uplifted by Police Investigations and Review Commissioner at the conclusion of your examination.

Please note that the Crown has not relinquished the right to prosecute in respect of the death of Mr Bayoh. As such, whilst corroboration is not required for the purposes of the Inquiry, forensic protocols intended to prevent cross-contamination should be observed.

We should advise that the boots and vest were (in 2015) examined for blood using the Kastle-Meyer test. In addition the vest was examined for fingerprints (again in 2015) and black magnetic powder and a wet chemical treatment (black powder suspension) were applied. If there is any possibility that these chemical applications could affect your own work, please advise. No previous substance/soil analysis has been carried out.

Instructions

Please provide a copy of your full, up-to-date curriculum vitae.

The Chair to the Inquiry will require to determine whether, as a matter of fact, Mr Bayoh stamped on the back of a female officer as she lay on the ground. The evidence before the Inquiry is in conflict. Against this background, we would be obliged if you could produce your full written report by conducting the following:

- I. A forensic soil/substance analysis to identify the substance that is on the vest;
- II. A forensic soil/substance analysis to identify any substance that is on the soles (or other areas) of Mr Bayoh's boots; and

III. An analysis as to whether the substance on the vest matches any substance found on the soles (or other areas) of Mr Bayoh's boots.

The suggestion has been made that PC Craig Walker might have stood on the female officer as she lay on the ground. We would therefore be obliged if you could carry out the following additional work:

- I. A forensic soil/substance analysis to identify any substance that is on the soles (or other areas) of the boots worn by PC Craig Walker; and
- II. An analysis as to whether the substance on the vest matches any substance found on the soles (or other areas) of the boots worn by PC Craig Walker.

Please identify any material assumptions made by you in carrying out your work. In preparing your report, you may find it helpful to have regard to the summary within Part 35 of the Civil Procedure Rules. Although the Rules are not in force in Scotland, they provide useful guidance on the role of an expert witness both north and south of the border. We have included the Civil Procedure Rules within the appendix to this letter.

In the event you require any further information, to assist with the completion of your report, please bring this matter to the attention of the inquiry team as soon as possible.

We would be grateful if you could produce your full written report in draft by the end of September. Counsel to the Inquiry would like to consult with you on the terms of your draft report in October. In the meantime, please provide us with your fee estimate once you have had an opportunity to review our instructions and the enclosed productions and papers. The Inquiry will be responsible for paying your fees in relation to your report and the presentation of your evidence - this incudes attending the hearing to give evidence.
