I am 34 years of age and currently employed as a Detective Constable within Levenmouth Criminal Investigation Department. I have completed 14 years of police service to date.

I have been requested to provide a statement in relation to my access to computer systems relating to the death of Sheku Bayou. This specific access relates to accessing records of Mohammed Zahid Saheed on the 3rd May 2015/

On Sunday 3rd May 2015 I was on duty in plain clothes as a Detective Constable in the Levenmouth area. During the course of my shift I was made aware of the death of Sheku Bayou in Kirkcaldy and colleagues of mine were taken to Kirkcaldy to assist

in the enquiries. DC Miller and I were left in the Levenmouth area to carry out local enquiries. We were later informed that our assistance was required in securing a property at Saeed home address as officers had been there and taken Saheed from this property.

As a result DC Miller and I attended at this property and assisted uniformed officers in clearing this property and then securing it (as per previous statement provided). This proved particularly problematic due to there being small children and a disabled man within. Also during this we moved a vehicle at the request of DS Dursley and this vehicle was registered to Saheed.

Once this was completed DC Miller and I returned to Levenmouth Police Station where we had to make several phone calls to family members of Saheed around the care of the disabled male, we also had to contact the social work regarding this. Once this was completed I compiled my statement regarding our involvement in this incident.

I can confirm that I accessed the crimefile details listed and although due to the time lapse I cannot recall accessing them this would have been to assist in compiling my statement and also to ascertain details and possible links to family members in order that we could arrange the appropriate care for the disabled male who stayed within the house and could not gain access due to it being secured.

I took no further part in this enquiry.
