LB Who would do the speeches.

AJ Myself and other sisters but still deciding on that.

LB What form do you think the video will take?

AJ Meeting this weekend. Because of short notice – just starting it now. Start this weekend.

AJ Filming is going to start on Friday – family and friends talking about who SB was to them, the impact he made in his life and also about the contribution they knew SB made to the community. Focus more about who he really was as a person so is going to take a journey from before born all the way to his death. He was with the family the night before – up to 10pm that night. Film of less than an hour.

LB You will all take part in it?

## AJ Yes -

LB One thing we need to make sure – the video works on our technology. We will need to have some sort of arrangement beforehand. CC happy – practise where speeches.

KJ Appreciate that – that is good.

LB SA and CC organise that for you. Helpful if a member of the legal team watch the video with you and see your speeches – nothing in them that might provoke and interruption or objection. Very pleased with your thinking.

KB Exactly as they have said – we will taking it from my mum all the way down – who he was and how he impacted our lives. Finalise things – having our recording on Monday.

SA I will get in touch with April and liaise re dates for rehearsal. Make sure the hearing room is available.

LB Think that will be a very strong start to the hearings. We won't do anything else that day.

KJ What time it will start? People have been asking us.

LB Follow normal court hours – 10 am – 4pm. Hour break between 1 -2 pm.
